As part of proactive measures to strengthen monitoring and detection of potential data compromise, the C-BRTA IT Division procured and implemented the NNT Log Track Changer solution. This automated system continuously monitors and tracks unauthorized or unplanned changes across C-BRTA business IT systems.

Key functions include:

- Flagging unplanned changes for immediate attention.
- Raising alerts to notify IT administrators of potential risks.
- Interrogating changes to determine what changed, when, by whom, and whether the change was authorized.
- Logging and marking all changes outside of approved change management processes.

This tool has become a critical component of the IT Division's security and compliance framework, ensuring that all system modifications are properly tracked and validated.

The current licenses for the NNT Log Tracker Enterprise 8 expired on 30 March 2026. The previous RFQ for the same was submitted in December 2025, however SCM has indicated the submission pack for appointment approval has been lost (and subsequently expired), and that the RFQ needs to be readvertised.

It is requested that the NNT Log Tracker Enterprise 8 license support maintenance be renewed for a period of 36 months. Given the importance of the NNT Log Track Changer in safeguarding C-BRTA's IT systems against unauthorized changes, it is strongly recommended that the licenses support maintenance be renewed for a further 36 months to ensure continued protection, compliance, and operational efficiency.

## **2.1 Activities to be monitored to include but not limited to the below.**

Change Tracker audits and monitors changes to:

- Files, file contents, file attributes and folder structures
- File secure hash value, to give a unique DNA fingerprint for each file, essential to detect trojan malware
- Running processes (checked against blacklists and whitelists)
- Windows registry keys and values
- Installed applications and patches
- Local and domain user accounts

- Services' start-up and running states
- Windows audit and security policy settings

**1. GENERAL CONDITIONS**

- 1.1 The following preference point systems are applicable to invitations to tender:

  - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).
- 1.2 The applicable preference point system for this tender is the **80/20** preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
- (a) Price; and
  - (b) Specific Goals.
- 1.4 The maximum points for this tender are allocated as follows:

- 1.5 Points for specific goals for this tender will be allocated on the basis B-BBEE Status Level as shown in Table 1 below.

- 1.6 In order to claim points for specific goals, bidders must submit B-BBEE Certificate and/or sworn affidavit, as the case may be.
- 1.7 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.8 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS
